The IARC reevaluated carbon black as a Group 2B carcinogen (possibly carcinogenic to humans) as the result of inhalation exposure test in rats. But, oral/skin test does not show carcinogenicity. (\*2) The evaluation of carbon black is based upon the development of lung tumors in rat receiving chronic inhalation exposures to free carbon black at level that induce particle overload of the lung.

The studies performed in animal models other than rats have not demonstrated an association between carbon black and lung tumors. Moreover, a two-years cancer bioassay using a typical toner preparation containing carbon black demonstrated no association between toner exposure and tumor development in rats. (\*1)
